KCL wtr. into tbg. Space out & set pkr. w/21,000# compression. RD BOP & nipple up well head. Displace 250 gals. 15% NeFe acid into perfs. by pumping intermittently, gradually increasing pressure to 2900 psig w/5.5 bbls. acid in perfs, pump 0.25 bpm @ 2900 psig. ISDP 2900 psig, 5 min. 2000 psig, 15 min. 1500 psig. RU to flow back well. Open well on 12/64" ck., flowed 1100 psig to 0 psig in 3 min. and died. RU to swab. Swab cups would not go. 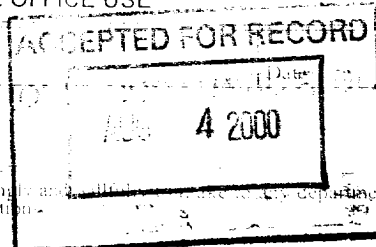
