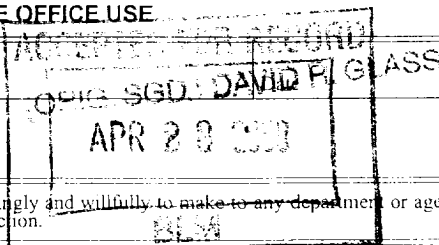

GENERAL INSTRUCTIONS
