6. SPOT 50 SXS @ 4250'-4150' & TAG
7. SPOT 35 SXS @ TOP OF SALT - 2200' +/-
8. PULL 8 5/8" CASING @ 1000' +/-
9. SPOT 65 SXS @ STUB & TAG
10. SPOT 85 SXS @ 450'-350'
11. SPOT 10 SXS @ 30' TO SURFACE - INSTALL DRY HOLE MARKER
12. RIG DOWN - CUT OFF WELLHEAD, ANCHORS & LEVEL PIT & CELLAR
