The operator proposes to plug back from Bone Spring perfs @ 9250-94' to the Delaware from 7220-7282' & 7306-56' by setting a CIBP @ 9240' w/30' of cmt on top by wireline bailer. The zone will then be acidized w/3000 gal 15% HCl & fraced w/220,000# 16/30 Ottawa & Resin coated sand.
