10/02/90 RU Wireline. RIH w/4" csg gun & perf 1 SPF as follows: 7586'-88', 91'-97' (10 shots). RIH w/RTTS & acidized perfs w/1000 gal 15% HCl. Form broke @ 2540 psi. Swabbed back acid.

10/3-7/90 Swabbed on well.

10/09/90 Acidized w/2500 gal gelled 15% HCl acid. Swabbed on well.

10/23/90 POOH w/tbg & RTTS.

10/24/90 MIRU Wireline. RIH w/4" csg gun & perf 1 SPF as follows: 7610'-22' and 7656'-66' (24 holes). RIH w/RBP, RTTS, & tbg. Set RBP @ 7642'. Set RTTS @ 7521'. Acidized w/1200 gal 15% HCl. RIH & latched on to RBP & reset @ 7675'. Set RTTS @ 7627'. Acidized w/1000 gal 15% HCl. PU and set RTTS @ 7604' and swab tested zones.

10/30/90 POOH w/tbg, RTTS, and RBP. RIH w/2 7/8" tbg and rods and put well on production.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
