12/17/89 Fraced well down csg w/70% 16/30 Ottawa and 30% 16/30 resin coated sand with 94,000 gal crosslinked gel, 188,340 # Ottawa & 72,000# resin coated.

12/19/89 Ran tubing and rods in hole.

12/20/89 Finished running rods and started pumping.
