Rel TA & POOH w/2 7/8" tbg, TA, 6 jts 2 7/8", SN & MA. LD 114 jts.

RU WL. RIH w/5 1/2" CIBP to 4920'. Set CIBP & dump 35' of cmt on top.

RIH w/4" csg gun & perf 7-Rivers 2 SPF (120° phased) from 3208-18', 3232-38', 3241-46', & 3252-60' (58 shots) & the Yates 2 SI

RIH w/pkr, SN, & 2 7/8" tbg to 3260'. Pickle tbg w/500 gal pickle acid.

Spot 3 bbls 15% NEFe across perfs. PU to 3110' & set pkr.

Acidize zone w/3000 gal 15% NEFe acid dropping 88 ball sealers evenly spaced. SI for 15 min and flow/swab back acid load.

Swab test zone.

Release pkr & POOH w/tbg & pkr. (If non-productive, set CIBP @ 3160')

RIH w/RBP, pkr, & tbg to 3100'. Set RBP & test to 3000 psi.

PU to 2860'. Spot 2 bbls 15% NEFe across perfs. PU to 2750' & set pkr.

Acidize zone w/1000 gal 15% NEFe acid dropping 36 ball sealers evenly spaced. SI for 15 min and flow/swab back acid load.

Swab test zone. Evaluate for additional stimulation.

RIH w/1 jt 2 7/8" tbg, SN, & 2 7/8" J-55 tbg to 3280' (EOT). ND BOP, & NU WH.

RIH w/sand screen, 2 1/2" x 1 1/2" x 26' RHBC pump, 84-3/4" & 45-7/8" Gr. D rods.

Space out and hang well on @ 10x100" SPM. RDMO PU.
