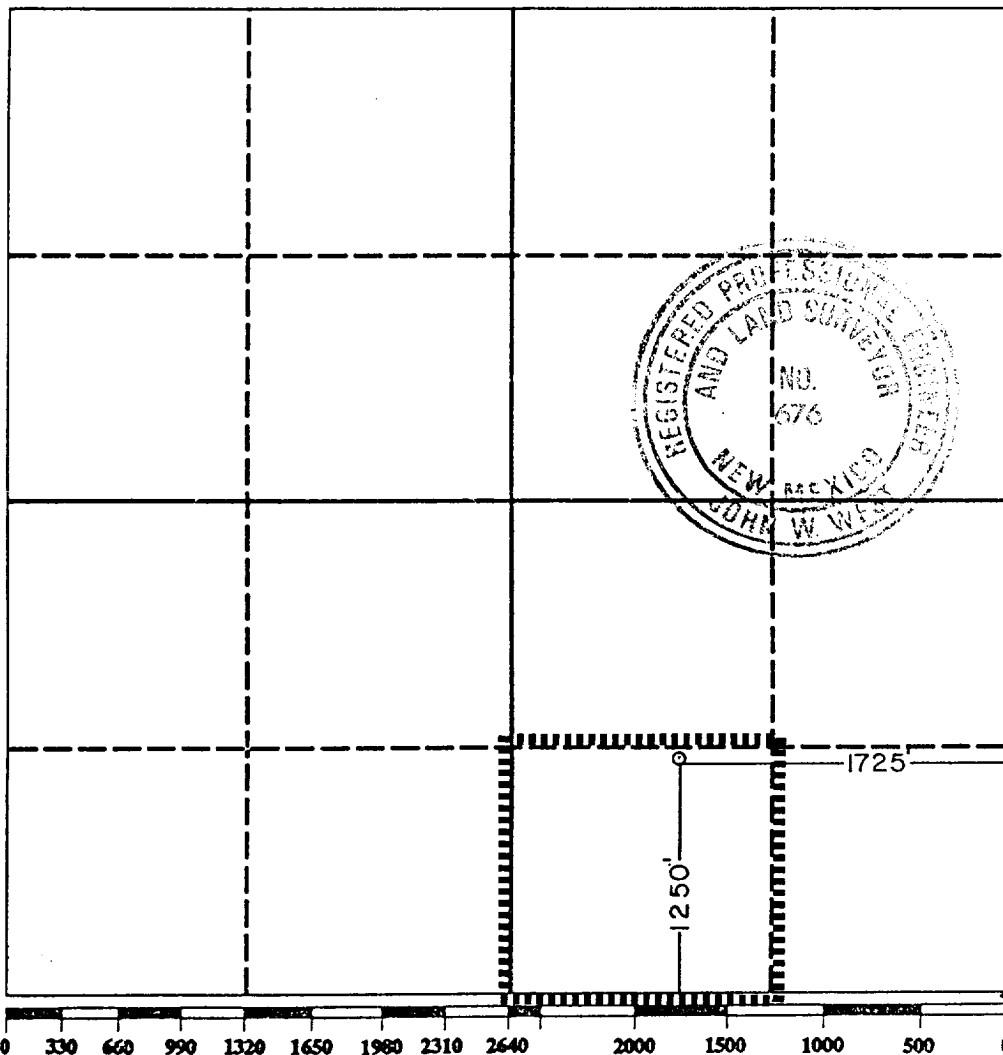

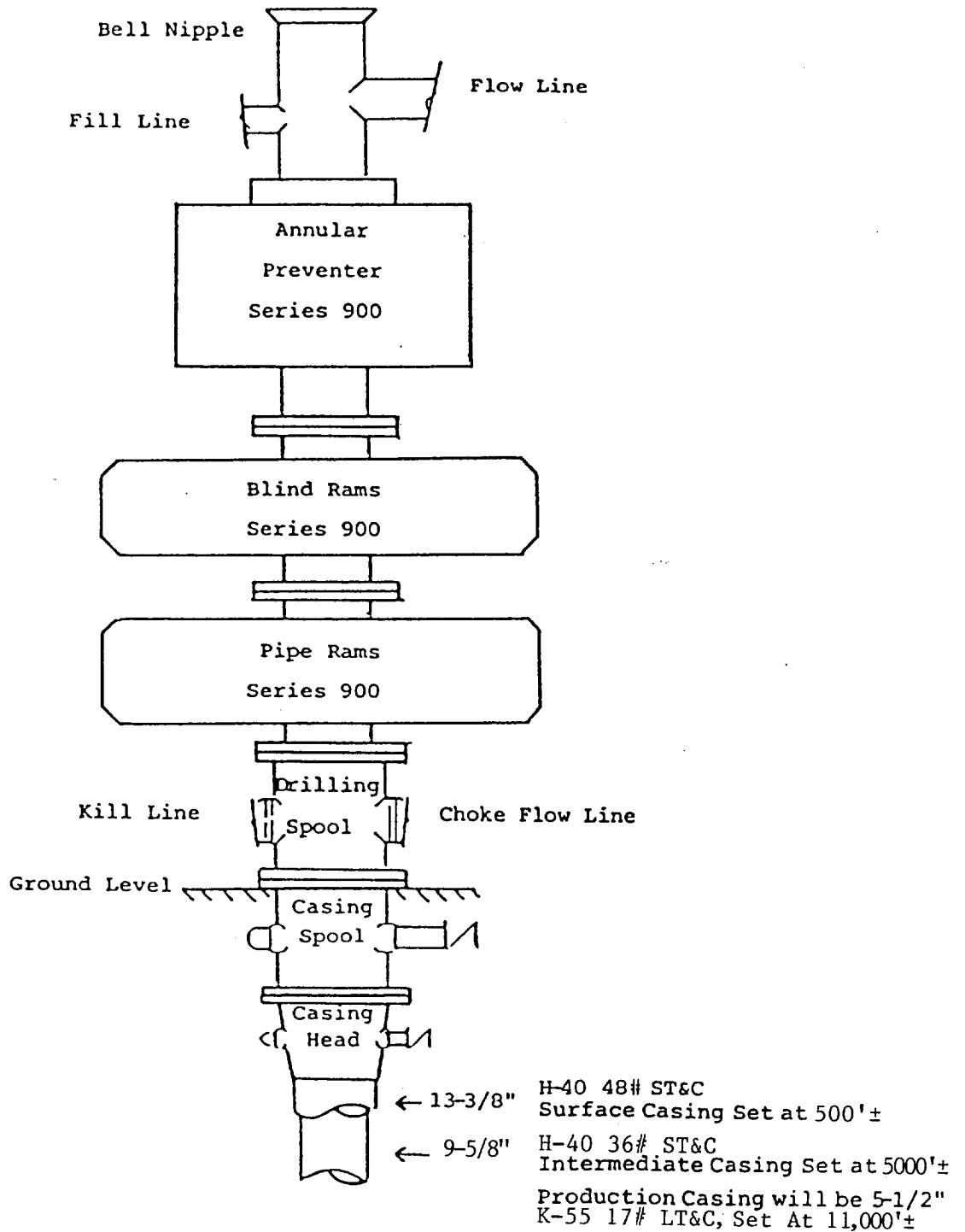
State Lease V-2526

The following items supplement the information on Form C-101:

1. PRESSURE CONTROL EQUIPMENT: Pressure control equipment will include a 5000#WP blowout preventer stack with annular preventer, blind rams and pipe rams. The BOP stack will include a kill line and choke manifold tested to 5000 psi. BOP hydraulic controls will be operated at least daily. Mud weight will be monitored to control bottom-hole pressure. A kelly cock will be installed on the kelly joint and full-opening safety valve will be available on the rig floor. A diagrammatic sketch of BOP stack is attached.
2. SURFACE DAMAGES: The well will be located on State surface leased by Mr. E.D. Shipp, 1104 West Avenue J, Lovington, New Mexico 88260. His telephone number is (505) 396-2152. A surface damage settlement will be negotiated with Mr. Shipp.
3. UNORTHODOX LOCATION: The unorthodox location has been approved by Order No. R-9351. The Order also approves the SW/4SE/4 Section 20 as a 40-acre oil spacing and proration unit for the pool.

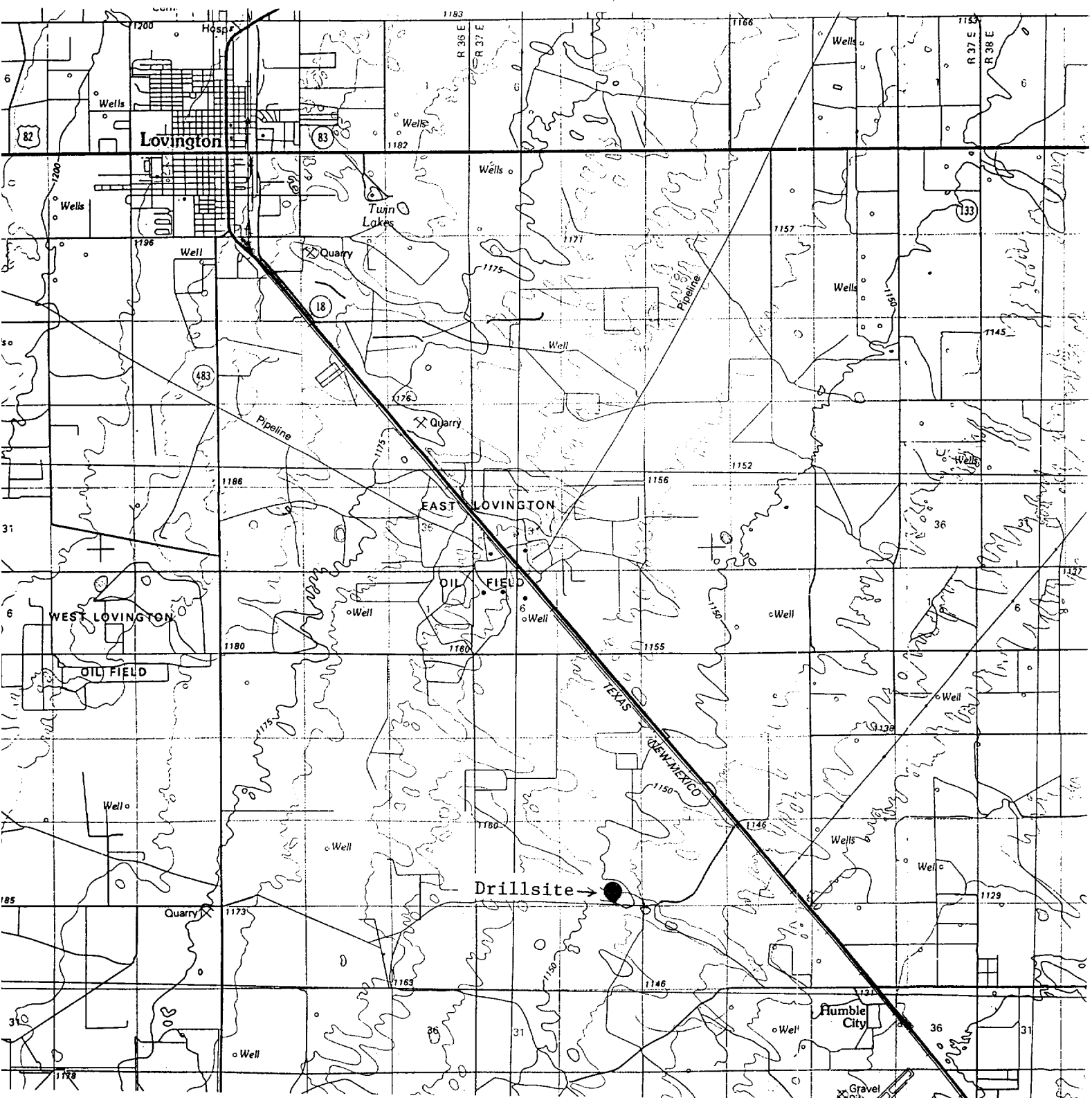
