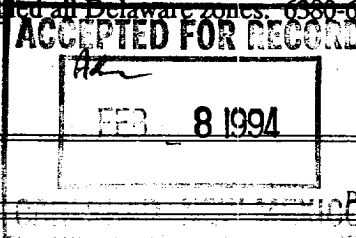

SPECIFIC INSTRUCTIONS
