Spudded well 9-5-91. Ran 44 joints of 24# J55 8 5/8" casing and set at 1870'. Cement with 700 sacks of Class "C" cement. Circulate to surface. WOC 15 3/4 hours. Test casing to 800 psi. Held OK.

Ran 150 joints of 5 1/2" 15.5# casing. Set at 6500' with 1550 sacks of Class "C." WOC greater than 24 hours. Test casing to 2000 psi.
