1. Run freepoint test to determine where 5½" casing is free (believed to be about 9,000').
2. Shoot 5½" casing off at freepoint.
3. Pull 5½" casing out of hole.
4. Rig up and "whipstock" well just above freepoint, drilling to approximately 12,150' with a 7-7/8" hole.
