Spud well 03/21/92. Ran 43 joints of 8-5/8" 24# casing and set at 1,830 ft. with 700 sacks of Class "C" cement. Circulate to surface. Waited on cement 9 hours. Tested casing to 800 psi. Held OK.

Ran 121 joints of 5-1/2" 15.5# casing and set at 5,230 ft. with 1,200 sacks of Class "C" cement. Circulated cement to surface. Waited on cement greater than 24 hours. Tested casing to 2,000 psi. Held OK. Total depth 5,230 ft.
