Spud well 03/24/92. Ran 31 joints of 8-5/8" 24# casing and set at 1,300 ft. with 550 sacks of Class "C" cement. Circulate to surface. Waited on cement 6 hours. Tested casing to 800 psi. Held OK. *MINIMUM 18 HRS*

Ran 146 joints of 5-1/2" 15.5# casing and set at 6,450 ft. with 1,400 sacks of Class "C" cement. Circulated cement to surface. Waited on cement greater than 24 hours. Tested casing to 2,000 psi. Held OK. Total depth: 6,450 ft.
