Spud well 5-22-92. Ran 31 joints of 8 5/8" 24# casing and set at 1300' with 500 sacks of Class "C" cement. Circulate to surface. Waited on cement 11 hours, however; compressive strength meets minimum requirements. Tested casing to 800 psi. Held OK.

Ran 114 joints of 5 1/2" 15.5# casing and set at 5160' with 1075 sacks of Class "C" cement. Circulated cement to surface. Waited on cement greater than 24 hours. Tested casing to 2000 psi. Held OK. Total depth 5160'.
