Spud well 04/17/92. Ran 31 joints of 8-5/8" 24# casing and set at 1,300 ft. with 550 sacks of Class "C" cement. Circulate to surface. Waited on cement 9 hours. Tested casing to 800 psi. Held OK. *MAILED 1842*

Ran 143 joints of 5-1/2" 15.5# casing and set at 6,450 ft. with 900 sacks of Class "C" cement. Circulated cement to surface. Waited greater than 24 hours. Tested casing to 2,000 psi. Held OK. Total depth: 6,450 feet.
