Texaco Exploration and Production seeks authorization to commence drilling and horizontal injection in its Vacuum Glorieta West Unit Well No. 93 (API No. 3002531810) located in Unit K of Section 36, Township 17 South, Range 34 East, NMPM, Lea County, New Mexico. This well is an injection well in the Vacuum Glorieta West Unit Waterflood Project which was approved by Order No. R-9714 dated September 3, 1992.

In mid 1998, Texaco obtained from the Division temporary authority to conduct a six month injectivity test into two horizontal laterals in its Vacuum Glorieta West Unit Well No. 108. On February 4, 1999 in Case 12123, Texaco came before the Division and presented evidence in support of permanent authorization for horizontal injection in the Unit Well No. 108 and also sought an administrative procedure whereby additional wells can be used for horizontal injection in a "Horizontal Injection Project Area" located in the southern portion of the Vacuum Glorieta West Unit Waterflood Project. If The Division approves the Horizontal Injection Project Area requested in Case 12123, applications of this nature can be handled administratively pursuant to division Rules 111 and 710.
