We plan to circulate cement to surface on the 14" and 8 5/8" casing strings. The cement top will be brought to approximately 1300' on the 5-1/2" casing string.

Devon Energy proposes to drill to 6000' to test the Queen and Penrose Sand formations for commercial quantities of oil. If the well is deemed noncommercial, the well bore will be plugged and abandoned per Federal regulations.
