Drld 7 7/8" hole and reached TD 5200' on 1/14/97 at 0230 hrs. Schlumberger ran LDT/CNL/DLL/MSFL/GR logs. Ran 122 jts 5 1/2" 15.5# J-55 LT&C csg, set at 5200'. Cemented w/1000 sx lite "C" + 550 sx Class "C". Circ'd 275 sxs cmt.
