3. Perforated Strawn formation on 1-6-98 from 12,214' - 12,224' at 4 JSPP.
4. Acidized with 4000 gals acid and flow tested at 59 BOPD and gas at TSTM.
5. TOOH with packer and RBP. Ran tbg open ended to 13,319'. *RBP taken out (4/98)*
6. Returned well to production with both zones open on 1-16-98 as per attached Application for Downhole Commingling (Acreage Dedication Plat is also attached).
