Spud 5/21/98 at 7:00am MST, Drilled 17 1/2" hole to 663', ran 13 3/8" x 54.5# surface casing to 663', cemented with 300 sks 35:65 poz, tailed in with 100 sks class C. Circulated 74 sks to pit. Drilled 12 1/4" hole to 4218', ran 9 5/8" x 40# intermediate casing to 4217', cemented with 1500 sks 35:65 poz with 8# salt, 5# /sk gilsonite and 1/4# CF, tailed in with 300 sks class C. Circulated 203 sks to pit. Drilled 7 7/8" hole to 10,300' TD on 7/17/98, ran logs, received verbal permission from Jim Amos to set 2 plugs as follows: 63 sks class H from 8020' --7920', second plug 63 sks class H from 6800' - 6700'.

Mallon Oil Company now requests a one year period of Temporary Abandonment for Geological and Engineering evaluation.
