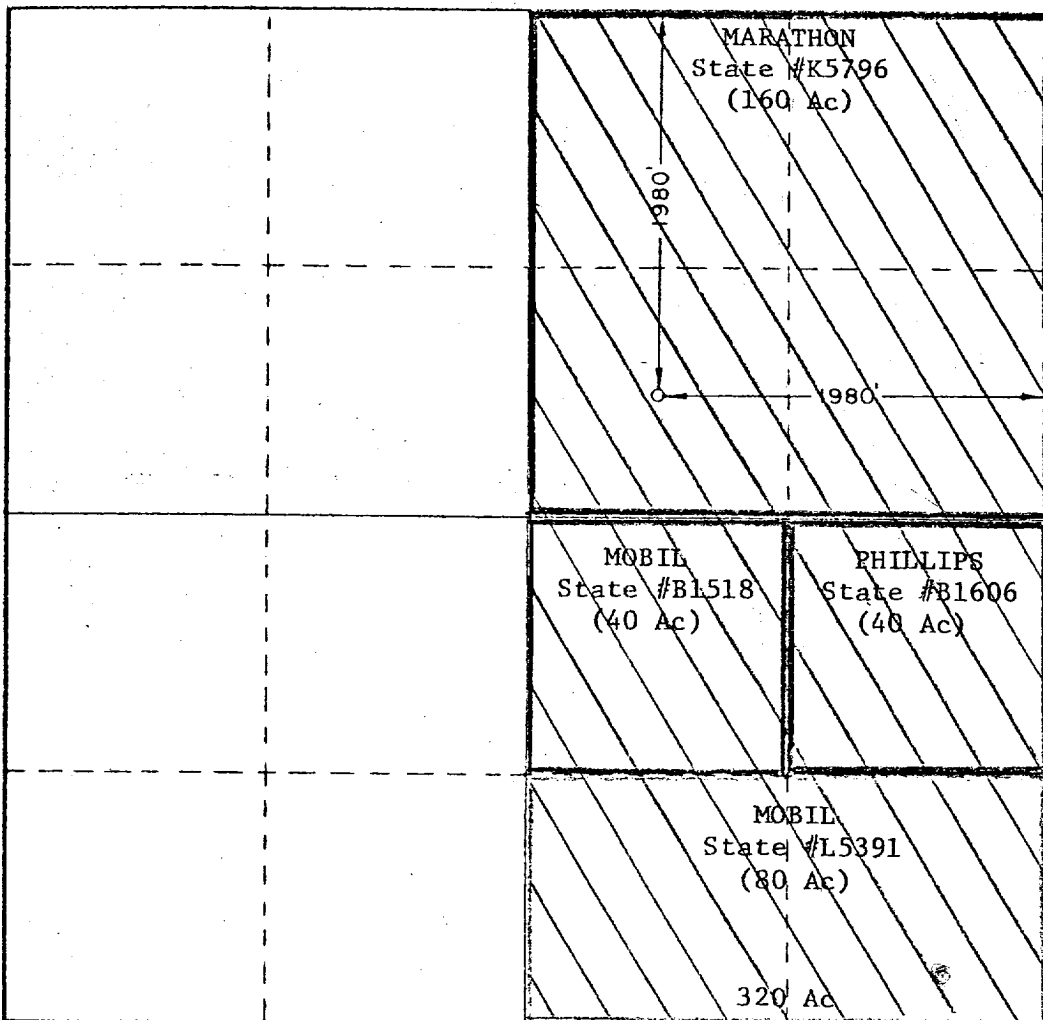

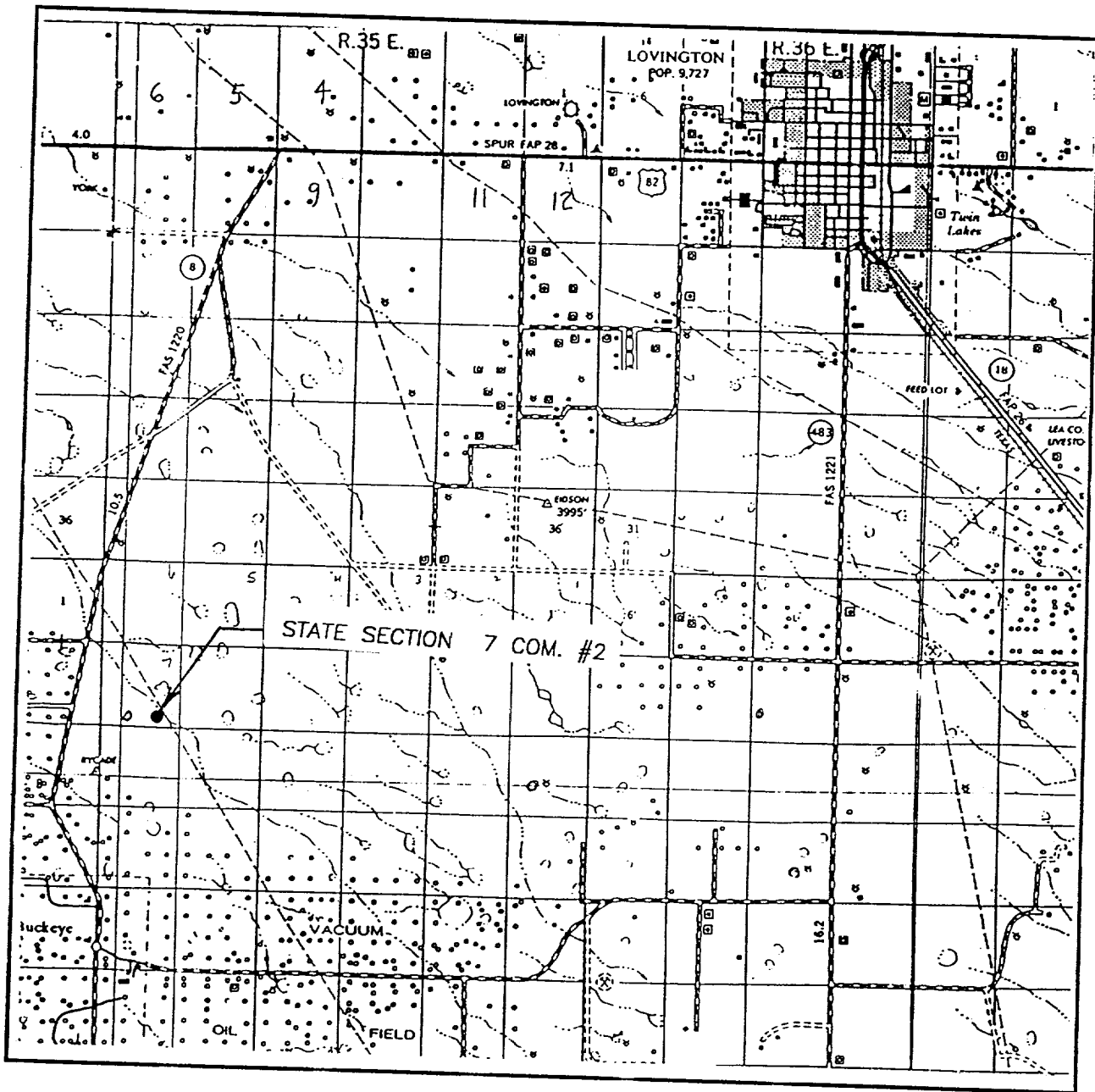

VICINITY MAP

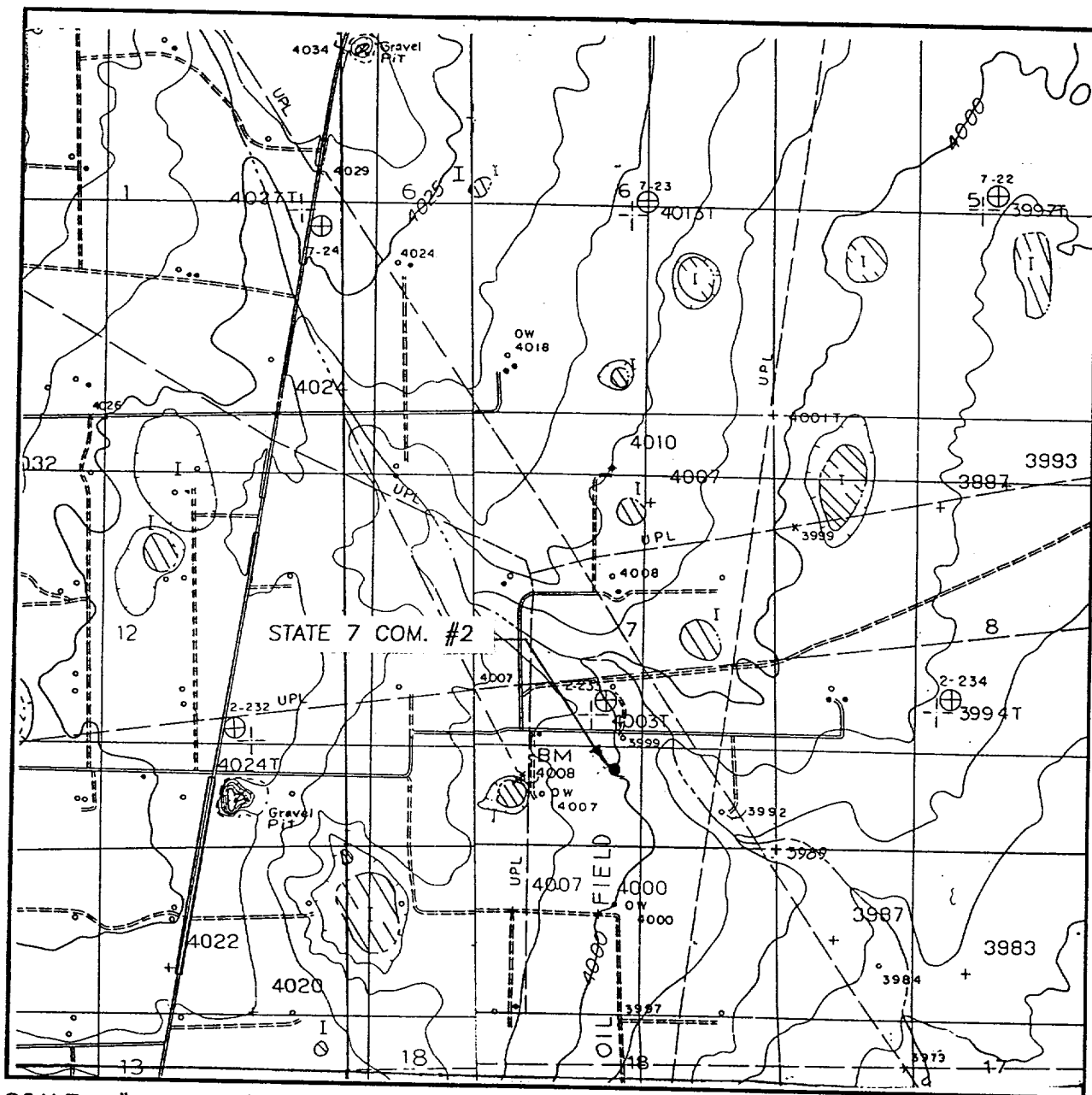
