This well not making enough oil to justify continued operation. There has been no production from it since we acquired it from Argo Oil Corp. We will follow plugging rules per your circular No. 6-A, setting cement plugs on top of pay, through the salt and on top of the ground, using Neafy Mud in between. Will cement plug of 10 sacks @ 2610 - bottom of 7" Will pull all recoverable 7" and fill hole with mud to 931 at which depth 8 5/8" is cemented and put 10 sacks cement and pull all 8 5/8" above this plug which is recoverable. Will fill hole with mud and cement regulation marker.
