2. Drilled Hydromite plug & cleaned out pea gravel to 3328'.
3. Set cement retainer @ 3200' & cement open hole section w/150 s s. Class 'C' w/2% CaCL, 1/4# floccle per s. and 100# Uni-beads. Squeezed cement to 2000 PSIG. 2-20-75.
4. Cemented from 3200' to surface w/10 s s. Halliburton light w/.5 of 1% CFR-2
5. Removed tubing head. Installed dry hole marker. RDPU.
6. Cut off dead men & leveled location 2-21-75. Well plugged and abandoned.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
