## DETAILS OF WORK

We propose to drill to a total depth of 5100 feet with rotary. The casing program will be as follows: We propose to set approximately 310 feet of 8-5/8 inch 24# J55 used surface casing and cement with sufficient cement to circulate. 5-1/2 inch 15.5# J55 new casing will be set at 5100 and cemented with 200 sack at bottom. A DV tool will be set at approximately 2100 feet and 100 sacks cement will be run through tool.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

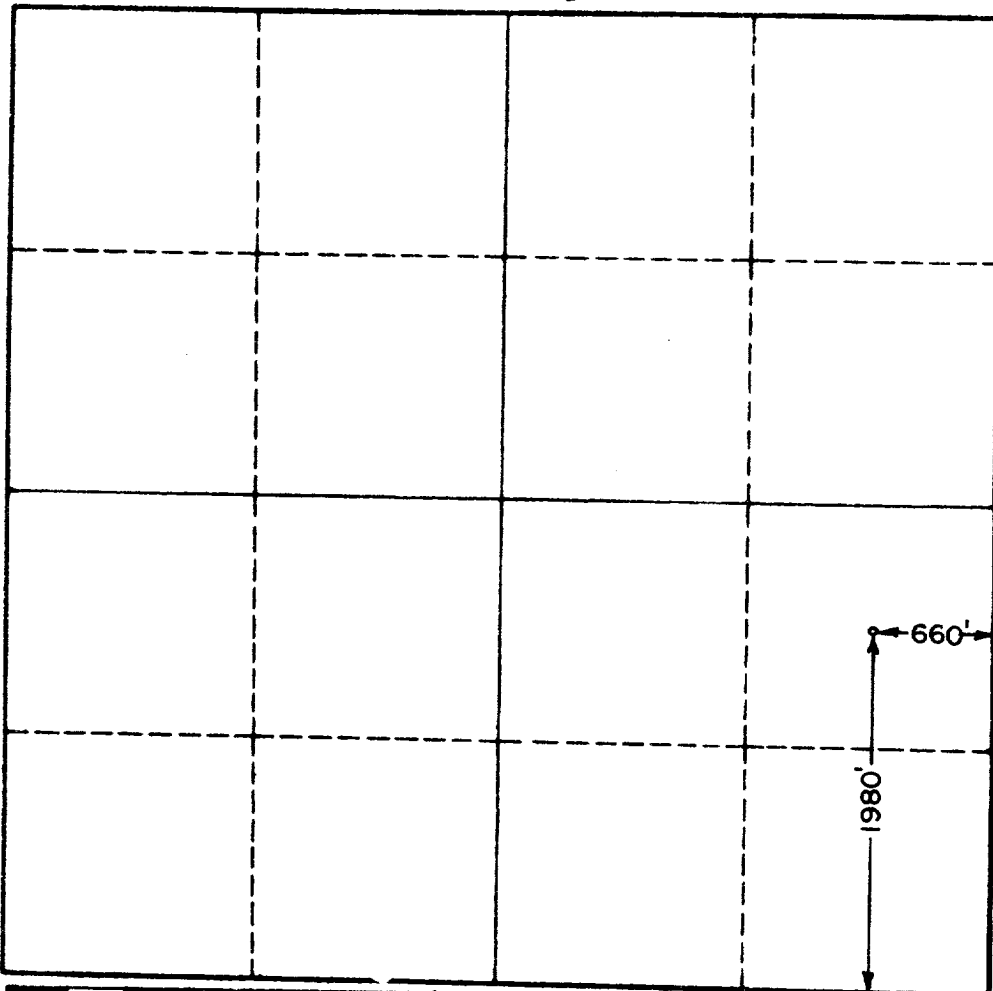
