DETAILS OF WORK

After WOC 30 hours bailed hole dry to test water shut off on 5 1/2 inch casing cemented at 3680 feet. Let stand 5 hours, no fill up. Checked top of plug at 3660. Drilled cement plug and cleaned out to total depth 3725 feet. Ran tubing and rods. Pumped 240 barrels oil, no water, 24 hours.
