1. Spotted 300 gallons 7 1/2% MCA on bottom.
2. Perforated 5 1/2" casing 4677' - 4687' w/2 jet shots per foot & 4792' - 4795' & 4838' - 4842' w/4 jet shots per foot.
3. Treated formation via casing w/30,000 gallons lease crude containing 3100# Adomite & 75,000# (20-40 mesh) sand in 3 stages using ball sealers.
4. Ran 154 jts. (4811') 2", EUE, 8rd thd, J-55 tubing & hung @ 4821'. Seating Nipple @ 4783'.
5. Ran 2" x 1 1/2" x 16' pump & recovered load.
6. On OPT pumped 83 BOPD, cut 0.4% BS, w/12.5-64" SPM.
