It is proposed to convert to water injection as follows: Install dual strings of 2-3/8" plastic coated tubing, one Guiberson Type "A" drillable packer set at approximately 4863' and one Guiberson Type "HLS-2" packer at approximately 4803'. (Packer will straddle perforations at 4830-36'). Land both strings in compression with 12,000 to 15,000#. Start injecting water.
