FULL DETAILS OF PROPOSED PLAN OF WORK
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

This well was drilled to 5060' with no commercial production resulting.
We plan to plug and abandon the well in the following manner:

1. Set 10 sacks cement at T.D.
2. Set 10 sacks cement at bottom of 7" pipe cemented at 4833'.
3. Cut pipe at approximately 3600' and set 10 sacks cement at stub.
4. Set 10 sacks cement at 3350' (base of salt)
5. Set 15 sacks cement at 1900' (top of salt)
6. Set 10 sacks cement at top of 13 3/8" surface casing
7. Weld standard dry hole marker to outside of 13 3/8" casing.
8. Clean up location.
