Clean out to 4933'. Drill deeper with 3-3/4" or 3-7/8" bit to approximately 4965'. Acidize with 400 gallons of 15% NE acid and frac with 5000 gallons of gelled water. Run tubing and rods and return well to production. Well will be converted to water injection at a later date.
