FULL DETAILS OF PROPOSED PLAN OF WORK  
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

1. Pull rods, pump and tubing.
2. Perforate Zone I at 4746-4752' with two JSPP;  
IIIB at 4966-4968' with four JSPP.
3. Run tubing with packer and set packer @ 4800'. Test for communication.
4. Treat Zone I perforations above packer with 500 gallons 15% Fe NEA.
5. Pull tubing and packer.
6. Set permanent packer at 4800'.
7. Run 1 1/2" tubing with dual packer spaced to set at 4710' with 2" plastic coated tubing below packer with seal assembly. Set packer.
8. Run 1 1/2" tubing with seal assembly.
9. Hook up plastic coated well head and start injecting.
