### FULL DETAILS OF PROPOSED PLAN OF WORK (FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

1. Pull rods, pump and tubing.
2. Perforate Zone IIA at 4870-4871' and 4879-4882' with two JSPF and at 4887' and 4894' with two JS each;  
IIIA at 4914-4916' and 4924-4926' with two JSPF.
3. Run tubing with packer and set packer @ 4800' between Zones I and IIA and test for communication.
4. Set permanent packer at 4800'.
5. Run 1 1/2" plastic coated tubing with dual packer spaced to set at 4710' with 2" plastic coated tubing under packer with seal assembly. Set packer.
6. Run 1 1/2" plastic coated tubing with seal assembly.
7. Hook up plastic coated well head and start injecting.
