2. Cut & pull 5 1/2" csg as deep as possible
3. Spot 50 sxs of cmt in & out of stub & tag
4. Spot 50 sxs of cmt @ 290' - 200' & tag
5. Spot 10 sxs of cmt @ surface
6. Install dry hole marker
