

Reference is made to Administrative Order NFO-267, dated July 7, 1956, granting the Phillips Petroleum Company permission to flare or vent low pressure gas from its Monument Well No. 2, located in the SW/4 NW/4 of Section 12-19S-36E, Lea County, New Mexico, in the Eumont Gas Pool.


We wish to advise that we are still working on arrangements for the sale of casinghead gas from this lease. The nearest gas gathering line for this low pressure gas is at such distance as to require detailed consideration of the feasibility of extending it to include the subject lease.

For your further information, gas production from Well No. 2 has declined to 17.91 MCF per day.

In the event a connection is made for the sale of gas from the subject well, this office will file a revised Form C-110 with the Commission.
