Gentlemen:

Due to the recently submitted scheduled Gas-Oil Ratio Test the above-referenced well will be reclassified from gas to oil effective July 1, 1993, and the gas allowable cancelled on that date. Althou the Operator's Production report C-115 shows the well to be gas.

If for some reason you feel this test does not reflect the proper classification of this well, please submit another test for our consideration by May 10, 1993.


If the well is to be reclassified from gas to oil you will need to file the following:

- 1.) Revised Form C-102, acreage dedication plat, outlining 40 acres for this oil well completion.
- 2.) C-104 showing reclassification from gas to oil effective July 1, 1993 and changing the transporter to oil & casinghead gas.
