7" casing set at 3700'

In order to increase productivity of this well, we have plugged back from 4017' to 3925' in the following manner: set 125 sacks from bottom to 3985', set 75 sacks, fill up to 3870' and drill out to 3925', sandfrac 3700' - 3925' with 10,000 gallons lease crude and 10,000 lbs. sand, plus 500 gallons mud acid. Flowed 19 hours on test ending 7:00 A.M. 5-13-55, 2571 MCF through a 3/4" choke, producing from Penrose Queen.
