February 13, 1984 to February 17, 1984 - Pulled rods, pump & tbq., Ran 4-3/4" bit on 2-7/8" tbq. & checked top of fill in open hole at 3929'. Selectively perforated G/SA zone in open hole fr. 3825' to 3928'. Ran pkr. & tbq. & set pkr. at 3760'. Acidized G/SA zone in open hole fr. 3808' to 3939' w/2500 gal. 15% NE acid using rock salt as diverter. Swabbed load. Re-ran tbq., pump & rods and resumed production.
