## DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

DUPLICATE

6-5/8" 20# 10-Tnd. New seamless Casing was set in this well at 3817' and cemented by the Halliburton method with 100 sacks.

Casing and fittings were tested with 1200# pump pressure and allowed to stand undisturbed for thirty minutes. No drop in pressure resulted so the cement was then drilled out of casing and the same test of 1200# pressure again applied and allowed to stand undisturbed for thirty minutes. No drop in pressure resulted. The drilling was then resumed.
