09/17/02 RIH w/ tbg, no tag. POOH w/ tbg and RIH 5 1/2" HM tbg-set CIBP to 3,959'. RU cementer and set CIBP. Loaded hole w/ mud and pumped 25 sx C cm t3,959 - 3,718'.
