DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

3262' - Total Depth - Anhydrite. Ran Temperature Survey - Top of cement on outside of 7-5/8" casing 2240', actual fill 1022', ratio of actual to calculated fill 35.7%. Ran 6-3/4" bit and found top of plug at 3170'. Tested 7-5/8" casing with 800# for 1/2 hour - No pressure drop. Drilled out cement plug and tested casing with 800# for 1/2 hour - No pressure drop. Started drilling formation and 6-3/4" hole at 3:45 A.M., 12-21-49.
