## DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Ran 9 Jts (294') 9-5/8" OD 32.30# Gr H-40 SS casing. Set and cemented at 311' with 275 sacks Regular Neat Cement. Plug at 291'. Maximum pressure 200#. Circulated approximately 10 sacks cement. Job complete by B J 9:30PM 12-31-54.

After waiting over 24 hours, tested 9-5/8" casing with 1000# for 30 minutes. There was no drop in pressure. Drilled cement plug from 291' to 311'. Tested below casing shoe with 400# for 30 minutes. No drop in pressure.
