FULL DETAILS OF PROPOSED PLAN OF WORK **(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)**

Proposed Operation:

1. Kill well. Pull tubing & packer. If any scale is recovered from tubing, have it analyzed for reaction with acid and/or sulfate removal chemical.
2. Run 1-50 grains/foot followed by 1-100 grains/foot string shots over perforated interval 3840' - 3935'.
3. Acid treat if no scale is found on tubing or if the analysis of the scale indicates it to be soluble in acid. Treat 2/2000 gallons 15% NE acid down tubing at maximum injection rates. If analysis indicates the presence of sulfate scale, a different chemical will be recommended.
4. Swab load.
5. Place on production.
