2. Pressure test casing to 3600 psi.
3. Treat via casing w/36000 gallons lease oil containing 1 1/2# sand and 1/20# Adomite per gallon using ball sealers.
4. Bleed off pressure, run tubing and swab test.
5. Place on production.
