## DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

1 1/2" 40# 8-thd. New Lapweld casing was set in this well at 188' and cemented by the Halliburton Method with 180 sacks.

Cement was drilled out of the casing and the hole bailed dry and allowed to stand undisturbed for thirty minutes. The bailer was then run to bottom again to determine if any water had accumulated. No water had accumulated so the drilling was then resumed.
