**Propose to pull rods and tubing, set a C.I. retainer at approximately 3730' and squeeze present casing perforations from 3740' to 3760' with 50 sacks cement. Perforate 7" OD casing from 3718' to 3724' with 2 shots per foot. Run 2-7/8" tubing with packer and swab test. If necessary, treat above perforations with sand oil fracture of 5,000 gals. refined oil and 5,000# sand and swab test.**
