3900' Total depth. Broken line. Set 2 1/2" upset tubing at 3897'. Swabbed in and flowed 32 barrels oil on 40 minute test. Through 1" open choke on 2 1/2" tubing. Gas volume of 12,000,000'. Killed well with water. Pulled tubing and re-run same with packer. (Robinson Rubber 2 1/2" X 4 1/2" X 40") Set packer at 3866' w/ perforations below. Swabbed in and flowed 403 barrels pipe line oil on 4 hour and 50 minute test. Hourly average of 83 barrels. Flowing through 1" open choke on 2 1/2" tubing. Daily gas rate of 945,000'. Gas oil ratio 406. Tubing pressure 180#. Casing pressure 200#.
