Pulled rods & pump. Checked fill inside 7" csg. at 3708' & pulled tbg. Ran pkr. & tbg. & set pkr. at 3424'. Tested tbg. w/2000#. Held OK. Loaded annulus w/109 bbls. 2% KCl water & press. to 500#. Acidized G/SA zone thru 7" csg. perf. fr. 3528' to 3698' w/2500 gal. 15% NE FE acid using ball sealers. Swabbed load. Re-ran tbg., pump & rods & resumed pumping.

Test of 7-28-83: Pumped 3 b.o. & 8 b.w. in 24 hrs. on 7-44" SPM.
