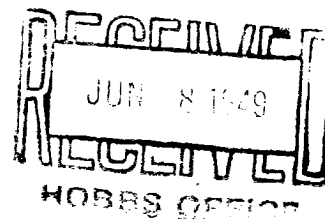

Reports on minor operations need not be signed and sworn to before a notary public. See additional instructions in the Rules and Regulations of the Commission.

Drilled to T.D. 2786', ran and cemented string of 9-5/8" OD casing at 2786' with 1500 sacks of cement. Halliburton process used and cement circulated back to surface. Let set 48 hours and on June 3, 1949 at approximately 2:00 P.M. drilled plug and tested casing shut-off. Shut-off tested O.K.. New drilling ahead.
