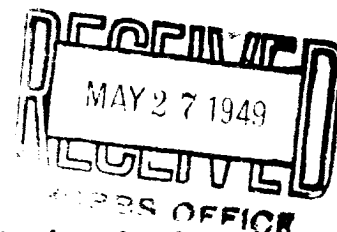

DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Drilled to T.D. 324', ran and cemented string of 13-3/8" OD casing at 324' with 420 sacks of cement. Halliburton process used and cement circulated back to surface. Let set 36 hours and on May 25, 1949 at approximately 11:30 A.M. drilled plug and tested casing shut-off. Shut-off tested O.K. Now drilling ahead.
