Eliminate pressure on casing strings at the surface

1. Rig up. Install BOP. Pull tubing.
2. Pressure test for casing leaks.
3. If leaks are found in 5½" or 7 5/8" csg.:
 - a) Set RBP below leak w/ sx. sand on plug.
 - b) Perforate & set cement retainer above leak.
 - c) Squeeze w/ cement as needed. WOC. DOC. Test.
4. Pressure test 10 3/4" - 15½" csg. annulus & bradenhead squeeze as necessary.
5. Test. Pull RBP.
6. Install production equipment. Return to production.
