### DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

3907' Plugged Back Depth. Swabbed 4 $\frac{1}{2}$  hrs. and well kicked off first on 32/64" and then 20/64" choke. In 21 $\frac{1}{2}$  hrs. to 6:00AM, 9-5-48 well flowed 54.66 bbls. oil and 474.50 bbls. water, GOR 16929. In next 24 hrs. flowed 25.12 bbls. oil and 64.58 bbls. water, GOR 18392. Killed well and tried to set formation but plastic plug soft. Ran bit and washed out soft plastic to 3918'. Tried to set 2-5 $\frac{1}{2}$ " formation packers at 3775' but would not hold. Ran 5 $\frac{1}{2}$ " but hit bridge at 2067'. Cleaned out to bottom ~~in~~ with 5 $\frac{1}{2}$ " bit and ran Halliburton Calipers. Found 8" hole 3736'-3822'; gradual reduction to 5-5/8" hole 3822'-26'; 5 $\frac{1}{2}$ " hole 3826'-3918'. Set Murphy Plug at 3820', dumped 98 gals. gravel, 40 gals. Ottawa Sand with 10 gal. Plastic cap at 3771'. Squeezed with 125 gals. plastic, 1300# dropped to 800# and held for 5 minutes, 70 gal. penetration, top plastic @ 3741' at 1300#
